Dear Ms. McNeal:

Pursuant to Rule 4906-5-08(A) of the Ohio Administrative Code, Carroll County Energy LLC files this Pre-Application Notification Letter regarding its proposed 700 MW combined cycle generation facility in Washington Township, Carroll County, Ohio with the Ohio Power Siting Board.

The proposed 700 MW combined cycle generation facility will be powered by natural gas and will be located on approximately 77 acres of privately owned land which is adjacent to a 23 acre site available for construction lay down. The site will be in Washington Township, Carroll County, Ohio with access off of State Route 9 and will be located near an AEP 345 KV transmission line. The purpose of the project will be to generate electricity for delivery and sale to the interstate transmission grid. The proposed project will utilize two General Electric 7 FA Series 5 gas combustion turbine generators each with a heat recovery steam generator (HRSG), and a single steam turbine generator.

The public informational meeting will be held from 6:00 PM to 8:00 PM on August 22, 2013 at the Carrollton High School, Fine Arts Room, located at 252 3<sup>rd</sup> Street NE, Carrollton, Ohio 44615.
