Change in Qualifying Facility Status

Dear Secretary Bose:

Covanta Fairfax, Inc. (“Covanta Fairfax”) owns and operates a municipal solid waste generator located in Lorton, Virginia (the “Fairfax Facility”), which the Federal Energy Regulatory Commission (the “Commission”) certified as a qualifying small power production facility (“QF”) pursuant to Part 292 of the Commission’s regulations<sup>1</sup> by order dated October 27, 1987.<sup>2</sup> Covanta Fairfax most recently submitted a Notice of Self-Recertification for the Fairfax Facility on March 3, 2004 in Docket No. QF87-605-001. Covanta Fairfax hereby notifies the Commission that it no longer operates the Fairfax Facility in a manner which allows it to qualify as a small power production facility. Specifically, the Fairfax Facility’s output now exceeds 80 MW. Therefore, Covanta Fairfax would like the Commission’s records to reflect that the Fairfax Facility no longer has QF status.
