Dear Ms. Watson:

On December 17, 2014, PJM Interconnection, L.L.C. (PJM) submitted an executed interim Interconnection Service Agreement (ISA) among PJM, Conetoe II Solar, LLC (Conetoe), and Virginia Electric and Power Company (Virginia Electric) (Conetoe Interim ISA).¹ You state that PJM is submitting the Conetoe Interim ISA for filing because it contains language that does not conform to the form of ISA set forth in Attachment O-1 of the PJM Open Access Transmission Tariff.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. § 375.307, your submittal is accepted for filing, effective November 19, 2014, as requested.

The filing was noticed on December 18, 2014, with comments, interventions and protests due on or before January 7, 2015. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2014)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
