Dear Ms. Watson:

On December 23, 2014, PJM Interconnection, L.L.C. (PJM) submitted an executed Wholesale Market Participation Agreement (WMPA)¹ entered into among PJM, OneEnergy Wye Mills Solar, LLC (OneEnergy) and Delmarva Power and Light Company (Delmarva). PJM states that it is submitting this WMPA for filing because OneEnergy intends to engage in wholesale sales in PJM markets from a generating facility connected to Delmarva distribution facilities.

Pursuant to the authority delegated to the Director, Division of Electric Power Regulation – East, under 18 C.F.R. §375.307, your submittal is accepted for filing, effective December 11, 2014, as requested.

The filing was noticed on December 23, 2014, with comments, interventions and protests due on or before January 13, 2015. Pursuant to Rule 214 (18 C.F.R. § 385.214 (2014)), to the extent that any timely filed motions to intervene and any motion to intervene out-of-time were filed before the issuance date of this order, such interventions are granted. Granting late interventions at this stage of the proceeding will not disrupt the proceeding or place additional burdens on existing parties.
