JOINT STATUS REPORT
AND REQUEST TO CLOSE DOCKET

Fresh Air Energy - X, LLC and Fresh Air Energy - II, LLC (collectively, “FAE”) and Virginia Electric and Power Company, in North Carolina as Dominion North Carolina Power (“DNCP”) by and through the undersigned counsel, hereby submit to the North Carolina Utilities Commission (the “Commission”) this joint status report and request to close docket.

The Commission’s February 19, 2015, Order Holding Docket in Abeyance and Requiring Status Reports directed FAE and DNCP, on or before April 1, 2015, to file a joint report on the status of their settlement negotiations informing the Commission of the progress made toward finalizing the settlement and executing power purchase agreements (“PPAs”). FAE and DNCP hereby notify the Commission that on February 18, 2015, the parties executed mutually acceptable PPAs for each of the three FAE facilities that were the subject of this arbitration proceeding. The execution of the PPAs resolves all matters at issue in this docket.

Therefore, FAE and DNCP respectfully request that the Commission issue an order closing this docket. Counsel for DNCP has consented to FAE's filing of this joint status report and request to close docket on DNCP's behalf.
