Dear Secretary Bose:

On February 26, 2013, the Commission issued an order authorizing Public Service Company of New Mexico's ("PNM") acquisition of a generating facility and associated jurisdictional assets.¹ On August 26, 2013, as modified on August 28, 2013, the Commission issued an order authorizing the cancellation of the Power Purchase Agreement ("PPA") between Delta Person, Limited Partnership ("Delta Person") and PNM.² In accordance with those orders,³ PNM hereby notifies the Commission that: (1) the purchase of the partnership interests in Delta Person was consummated and became effective on July 17, 2014; and (2) the transfer of the ownership of the Delta Person generating facility and associated jurisdictional assets to PNM will occur on July 30, 2014, which will be the effective date of the cancellation of the PPA.
