NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN AIR PERMIT

PROPOSED AIR QUALITY PERMIT NUMBER GHGPSDTX122

APPLICATION Rockwood Energy Center, LLC has applied to the Texas Commission on Environmental Quality (TCEQ) for issuance of Greenhouse Gas (GHG) Prevention of Significant Deterioration (PSD) Air Quality Permit Number GHGPSDTX122, which would authorize construction of a Power Generation Plant located at the southwest corner of the intersection of CR 111 and CR 116, approximately 5.0 miles northwest of Garwood, Colorado County, Texas 77442. The proposed facility will emit greenhouse gases.

This application was submitted to the TCEQ on December 5, 2014. The application will be available for viewing and copying at the TCEQ central office, the TCEQ Houston regional office, and the Eula & David Wintermann Library, 101 North Walnut Avenue, Eagle Lake, Colorado County, Texas, beginning the first day of publication of this notice. The facility's compliance file, if any exists, is available for public review in the Houston regional office of the TCEQ.

The executive director has determined the application is administratively complete and will conduct a technical review of the application.

PUBLIC COMMENT/PUBLIC MEETING You may submit public comments or a request for a public meeting to the Office of the Chief Clerk at the address below. You must submit comments to be eligible to participate in an appeal of a final action on this application. The TCEQ will consider all public comments in developing a final decision on the application. After the deadline for public comments, the executive director will prepare a response to all public comments.

The purpose of a public meeting is to provide the opportunity to submit comments or ask questions about the application. A public meeting about the application will be held if the executive director determines that there is a significant degree of public interest in the application, if requested by an interested person, or if requested by a local legislator. A public meeting is not a contested case hearing. There is no opportunity to request a contested case hearing for this application.

After technical review of the application is complete, the executive director may prepare a draft permit and will issue a preliminary decision on the application. Notice of Application and Preliminary Decision for an Air Quality Permit will then be published and mailed to those who made comments, submitted meeting requests or are on the mailing list for this application. That notice will contain the final deadline for submitting public comments.
