Dear Secretary Phillips:


Pursuant to Section 3.9 of the New York State Public Service Commission's regulations (16 NYCRR 3.9), to the extent applicable, Mohawk Solar LLC ("Applicant") is hereby submitting this Notice of Impending Settlement Negotiations for the above-referenced proceeding.

The Applicant and several parties, including the Department of Public Service ("DPS"), the Department of Environmental Conservation ("DEC"), and the Department of Agriculture and Markets ("DAM"), discussed at the procedural conference a period of time to negotiate and narrow issues in dispute in this proceeding. The issues to be discussed during settlement negotiations will include, but are not limited to, proposed certificate conditions and a proposed Site Engineering and Environmental Plan (SEEP) guide.

Settlement negotiations may take place between January 10, 2020 and March 27, 2020, at the offices of the Department of Public Service in Albany, New York, telephonically or at other locations as needed, and continue thereafter as may be necessary and appropriate. Notice of settlement conferences will be sent to parties electing to participate in the settlement discussions.
