Reply Brief-Concurrent	March 12, 2021
Request for Final Oral Argument/Close of Record	Concurrent with Reply Brief
Proposed Decision	Targeted for the Second week in June 2021

The proceeding will stand submitted upon the filing of the reply briefs unless the Administrative Law Judge (ALJ) requires further evidence or argument.

Stipulated Testimony and Exhibits are to be uploaded to the Commission's e-file website and served in accordance to Rule 13.7. The Commission's E-file System is accessible on the Commission website: <http://efile.cpuc.ca.gov/> and service should be to all parties on the service list. The parties may serve electronic copies of Stipulated Testimony and Exhibits to one another in lieu of paper copy, upon stipulation between parties. An electronic copy plus one paper copy of each Stipulated Testimony and Exhibit shall be served to the ALJ, except for the Final Environmental Impact Statement (FEIS). One paper copy and a thumb drive with the electronic copy of the FEIS shall be served to the ALJ.

For service of large files to the ALJ and CPUC staff, parties may serve electronic copies through Kiteworks.
